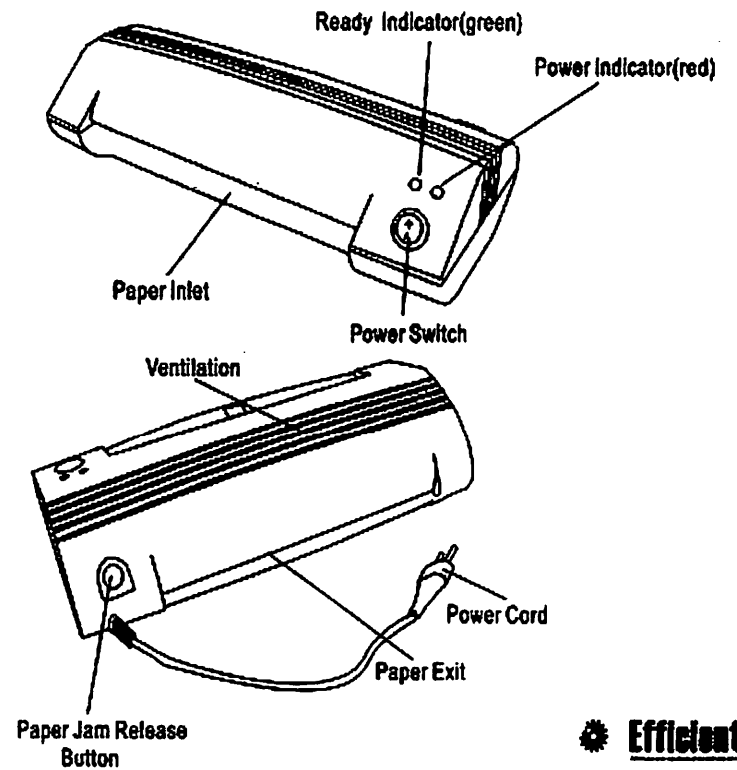

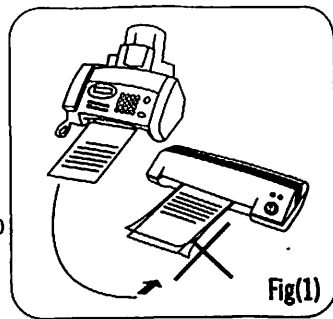

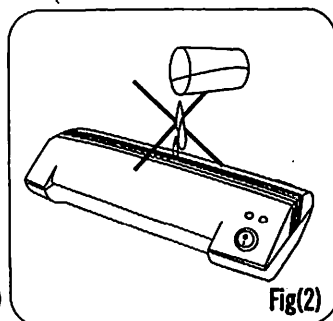

Important Safety Instructions PL2100

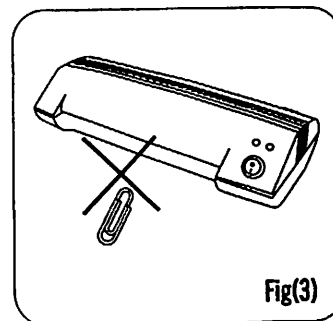
1. Read carefully this operation manual before operating the unit.
2. Never attempt to open and service the unit. No user serviceable part inside the Laminator.
3. Repair job must be done by authorized personnel. Un-authorized servicing of the unit will render the warranty impaired.
4. Use only the pouches as stated with the right thickness and size. Too thin the pouches will easily be caught and result in document jams.
5. Plug only the machine to the right socket and shall be easily accessible. Extension cord is not recommended.
6. Machine surface is hot during operation. Children operating the machine shall be supervised by adults.
7. Machine is designed and manufactured for indoor use only.
8. Whenever smoke or abnormal smell is detected, unplug the unit immediately and call for servicing.
9. Never laminate heat sensitive material with this machine, such as thermal fax paper. Laminating moisturized documents will result in poor laminates. (Fig 1)
10. Prevent spilling any liquid form substances into the machine. (Fig 2)
11. Never attempt to force any metallic items or your finger into the machine to prevent electrical/high temperature hazards. (Fig 3)

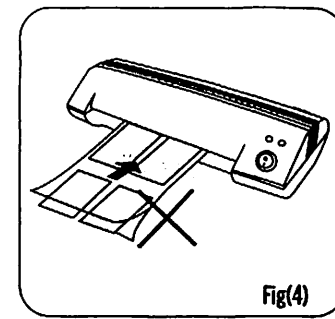

Laminating Guide

1. Plug the unit to the wall socket and turn on the main power switch. The RED indicator will be lighted up.
2. Wait until the GREEN indicator comes on, usually it takes about 5 minutes for the unit to be ready for lamination.
3. Insert the document into the pouch of the right size. Leave approximately 3 to 5mm at each side of the pouch.
4. It is highly NOT recommended to put several smaller documents into a large pouch, which may cause poor laminating effects and paper jams. (Fig 4)
5. Insert squarely the pouch, with the closed end first, into the paper inlet. (Fig 5)

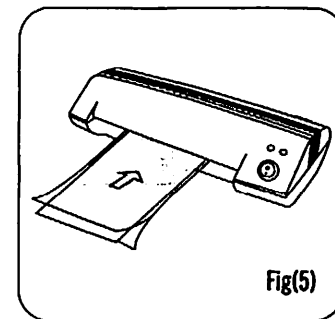
6. The laminated documents exiting the machine might still be hot instantly and precautions are required while handling.
7. It is recommended to laminate thin/soft material by pouches of thicker sleeves (e.g. 100 microns). Laminating newspaper by using pouches thicker than 100 microns definitely helps preventing the machine from jamming.

Jam Release

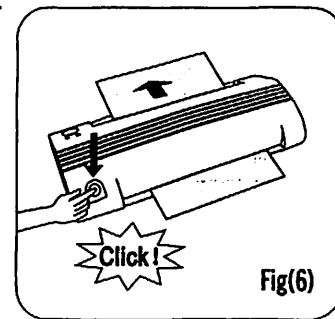
1. The machine is featured with a JAM RELEASE BUTTON to clear document jams.
2. Symptoms of Paper Jams
 - a. Documents failed to exit as usual
 - b. Abnormal noises noticed during operation
 - c. Document ceased to proceed on its way through the machine
3. Once document jam occurs, turn OFF the machine and press the JAM RELEASE BUTTON all the way down until you hear a very significant "click". (Fig 6)
4. Hold firmly the machine in place and pull the document out from the paper inlet until it is fully retracted.
5. The JAM RELEASE BUTTON will return to its original state once the machine is turned ON again. Machine operation will be restored.
6. If document jam repeatedly happens, contact authorized distributors for repair/advice.

Basic Machine Maintenance

1. Use only soft fabric with water or natural detergent to wipe clean the machine housings. Never apply any paint thinner and Benzene, which cause discolorations.
2. When wiping clean the power cord, care shall be taken not to wet the metal parts of the plug.

Trouble Shooting Guide

Symptoms	Measurements
No power, Indicators do not light up and/or no operation	Check the power plug whether correctly plugged into an operating wall socket. If confirmed everything is fine and machine still not working, call for repair
Document Jams	Verify thickness of pouches is as specified. Use only pouches of the specified thickness. Ensure that the document is inserted squarely into the machine. Follow the instructions in the Jam Release section to clear the jam.
Misty laminates	Laminate again the same document will help to improve
